4. Project/Program Description

The Town of Montverde plans to incorporate stormwater improvements and best management practices to reduce nutrient run off in the area lakes, with the most critical being Lake Apopka and Lake Florence, directly effecting the chain of lakes. The Town proposes to construct stormwater retention, detention, collection, and control to mitigate potential flooding and reduce phosphorous nutrient load entering the lakes of crucial importance. Stormwater improvements will include curbing and piping to collect stormwater run-off, detention/retention ponds to control flooding, and incorporate additional best management practices such as nutrient removal boxes where applicable. The proposed improvements will also provide an added public benefit of flooding reduction in the area by implementing collection improvements and allow the Town to control surface run-off more appropriately and effectively in an environmentally sustainable manner.

The goals of the proposed improvements are: (1) capture stormwater run-off before it enters area lakes of critical concern, (2) treat the stormwater utilizing filtration and nutrient removal technologies, (3) increase percolation of clean water into the Upper Floridan Aquifer, and (4) reduce local and downstream flooding.

Improved stormwater quality, quantity, storage and treatment creating a positive environmental benefit to Lake Apopka and Florence Lake.

Direct services provided to citizens include improved stormwater quality, quantity, and storage/treatment. The proposed improvements will also provide an added public benefit of flooding reduction in the area by implementing collection improvements and allow the Town to control surface run-off more appropriately and effectively in an environmentally sustainable and positive manner.

d. Who is the target population served by this project? How many individuals are expected to be served?

Town of Montverde - 1,655.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Removal of target pollutants identified in the Upper Ocklawaha Basin Management Action Plan to include phosphorus and nitrogen reduction in Lake Apopka and Florence Lake. Lake Apopka is 48 square miles, spring fed, and is the headwaters of the Harris Chain of Lakes listed as waterbodies of interest in the Upper Ocklawaha Basin Management Action Plan. The Town proposes to construct stormwater retention, detention, collection, and control to mitigate potential flooding and reduce phosphorous nutrient load entering the lakes of crucial importance. FDEP permitting requirements and compliance standards is the methodology by which this outcome will be measured.
