### 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The goal is to eradicate entanglement in the Criminal Justice System through advocacy and prevention, by educating members not to cross the lines of the law, and to address emotional, physical, and mental trauma caused by social disparities. YLLC recognizes young people's desire to belong and snatches them from the possibility of negative gang involvement into a positive mentoring leadership environment. Young Law Legal Club is a nonprofit organization that runs a law and legislation program and that educates its members on the United States Judicial System, the language of the law, the importance of voting, financial literacy, how legislation works and how laws can change.

### b. What activities and services will be provided to meet the intended purpose of these funds?

YLLC will conduct educational workshops/ training and mock trails with the use of our mobile courtrooms. Members will participate in trips to legislative sessions under our law pilot curriculum and our basketball program. Members will actively participate in our mock trial proceedings. Members will participate in prison tours to remind members not to cross the lines of the law. Members will participate in our mental health & nutritional screening/assessment with the assistance of YLLC's licensed therapist to proceed with a corrective plan of action to address mental health and physiology needs. Members will participate in our life skills curriculum reimagining life on priorities and principles. Members will learn socially acceptable behavior, improving personal and public safety.

### c. What direct services will be provided to citizens by the appropriation project?

Our evidence-based solutions have proven the importance of intervention and prevention by educating members not to cross the lines of the law. YLLC will provide counselors to locate adolescents in target populations and provide positive coping mechanisms under the supervision of our mental health coordinators. Members will have direct access to counselors, licensed mental health therapist, nutritionist, support groups, trainings, and workshops to assist them in learning the language of the law and to help deal with trauma. Members will participate in classes and workshops to give members the tools to invest in themselves, reducing recidivism, and giving members the tools not only to become productive employable citizens but to also become advocates in crime prevention.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Our target population are adolescents in grades 3-12 and young adults who fall under the following categories: persons with poor mental health jobless persons, economically disadvantaged persons, at-risk youth, homeless, developmentally disabled grade school students, high school students, University/College students, currently or formerly incarcerated persons, drug offenders (in criminal Justice), victims of crime.
