The funding will provide design and construction services for a wastewater pump station.

c. What direct services will be provided to citizens by the appropriation project?

Sanitary sewer service will be made available to commercial property owners within the project area.

d. Who is the target population served by this project? How many individuals are expected to be served?

The pump station will provide sanitary sewer service to approximately 33 commercial properties between SW 92 Ave. and 97 Ave. along Bird Road. This station can also support future sewer gravity expansion to properties within the pump station basin, which is roughly a square mile area, as additional funding or development occurs.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Removal of septic tank systems, a source of nutrient and bacterial pollution. The number of disabled septic tank systems will be tracked to determine outcome. This project also supports the economic development of this area by permitting for additional uses and business expansion for commercial properties that connect to the sanitary sewer system. This outcome can be tracked by the number of building permits issued
