## **Special Session 2022A**



#### Senate Bill 2A: Improving the Property Insurance Marketplace for Homeowners

Timely communications, investigations and payments of valid claims from insurers.

New optional state reinsurance program in anticipation of shortages.

One-way attorney fees eliminated to allow for both parties to obtain fees in judgment process.

Fortifies the Office of Insurance Regulation's regulatory authority over property insurers.

### Senate Bill 4A: Recovering and Rebuilding from Hurricanes Ian and Nicole

Provides property tax refunds for the portion of the year that homes were uninhabitable due to hurricane damage from Hurricanes Ian or Nicole.

\$150 million for affordable housing hurricane recovery efforts.

\$60 million to assist with the repair or replacement of housing, relocation costs, limited-time rental assistance, and other recovery needs, of which \$25 million may be used to provide assistance to homeowners to pay insurance deductibles.





#### Senate Bill 4A: Recovering and Rebuilding from Hurricanes Ian and Nicole

Bill appropriates funding through the Department of Environmental Protection for beaches and essential water infrastructure impacted by Hurricanes Ian and Nicole.

Bill creates the Florida Emergency Management Assistance Foundation, a Direct Support Organization (DSO) of the Division of Emergency Management (DEM).

Additionally, to help local governments secure FEMA grants, \$350 million is appropriated to the DEM to pay local match requirements.

#### Senate Bill 6A: Toll Savings for Florida's Families

Bill appropriates \$500 million for a statewide toll relief program for frequent commuters, beginning on January 1, 2023, through end of the year.

Customers using a two-axle vehicle with a Floridaissued transponder who use Florida's Turnpike System and all other toll facilities in the state are eligible.

Customers who engage in 35 or more toll transactions in a month will receive a 50% credit.
