a. What specific purpose or goal will be achieved by the funds requested?

Funds will be used to construct dune walkovers at up to five major points of public access for beaches on Captiva Island. This will occur in conjunction with beach renourishment and dune restoration efforts occurring on Captiva following significant beach damage that occurred as a result of Hurricane Ian. The walkovers will help protect the continuous integrity of the dune system including vegetative cover, and reduce previous points of vulnerability.

Dune walkovers will be constructed at up to five major points of beach access.

c. What direct services will be provided to citizens by the appropriation project?

Walkovers will maintain and in some cases improve the ease of beach access for both residents and visitors. Their installation will also ensure higher integrity of Captiva's dune system including vegetative cover that will result in decreasing vulnerability to future coastal flooding including from storm surge.

d. Who is the target population served by this project? How many individuals are expected to be served?

This project will benefit Captiva residents, businesses, and over 180,000 yearly visitors. More than 180,000 individuals are expected to gain benefits from this project on a yearly basis.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project will provide many benefits. Maintaining the integrity of Captiva's dune system including vegetative covering using walkovers will help enhance wildlife habitat, which can be monitored before and after constructing them. An intact dune system will decrease shoreline vulnerabilities to flood conditions and can help reduce the amount and intensity of water reaching interior island homes and businesses. This can be examined through monitoring island conditions after flood events. Walkways will likely maintain or enhance beach access, preserving or increasing visitorship and economic activity associated with tourism for Captiva and greater Lee County. This can be monitored through visitor satisfaction and tourism statistics.
