Constructed in the 1980's, the existing A-14 control structure did not provide the upstream basin with any water quality benefits. Using current South Florida Water Management District design standards, the proposed structure is designed to provide water quality treatment for the upstream A-14 Sub-Basins. Replacement of the critical stormwater structure will include water quality enhancements before discharge into the North Fork of the St. Lucie River Aquatic Preserve.

The City of Port St. Lucie is requesting funding for the A-14 Control Structure Replacement that will provide increased water quality treatment for the upstream basin. The A-14 Drainage Control Structure was originally constructed in 1981 and is no longer functioning as designed. The City will remove and replace the structure with a v-notch bleeder design. The proposed structure will provide the upstream A-14 Sub-Basins with approximately 26.63 acre-feet of water quality volume.

b. What activities and services will be provided to meet the intended purpose of these funds?

Demolition and total reconstructure to the original structure.

c. What direct services will be provided to citizens by the appropriation project?

Significant public safety improvement to insure that the structure will protect residents downstream of the facility to manage flooding potential.
