(a) Install a point of use filter that reduces the lead

15	1. The filter must be installed by a school district staff
16	member.
17	2. The filter or all of its component parts must meet the
18	NSF International/American National Standards Institute Standard
19	53: Drinking Water Treatment Units-Health Effects.
20	3. The filter must have a certified capacity of 7,900
21	gallons and, at a minimum, must be changed or replaced annually.
22	(b) Post a conspicuous sign near each school water source
23	that is not a drinking water source. The sign must include
24	wording and an image that clearly communicate that water from
25	the source should not be used for human consumption or, if
26	applicable, for food preparation or cooking.
27	(c) The district school board shall publish on its website
28	a list of drinking water sources at such schools. At a minimum,
29	the list must include, for each drinking water source, all of
30	the following:
31	1. The date on which the current filter was installed.
32	2. The date on which the current filter is scheduled to be
33	replaced.
34	3. The location of each drinking water source.
35	4. Any actions necessary to comply with the requirements of
36	this section which have been completed or are pending.
37	(4) Each district board as defined in s. 153.52 may request
38	additional funds for the purpose of compensating school district
39	staff for the installation or replacement of filters. Funds
40	provided pursuant to this subsection may not be more than the

42	(5) The State Board of Education shall adopt rules to
43	administer this section.
44	Section 2. For the 2020-2021 fiscal year, the sum of $\$3$
45	million in nonrecurring funds is appropriated from the Drinking
46	Water Revolving Loan Trust Fund to district boards as defined in
47	s. 153.52, Florida Statutes, for the purpose of implementing s.
48	1013.29, Florida Statutes, as created by this act.
